**SUPPLEMENTARY INFORMATION:** The OMB is particularly interested in comments which:

- Evaluate whether the proposed collection of information is necessary for the proper performance of the functions of the Corporation, including whether the information will have practical utility;
- Evaluate the accuracy of the agency's estimate of the burden of the proposed collection of information, including the validity of the methodology and assumptions used;
- Propose ways to enhance the quality, utility, and clarity of the information to be collected; and
- Propose ways to minimize the burden of the collection of information on those who are to respond, including through the use of appropriate automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, *e.g.*, permitting electronic submissions of responses.

#### Comments

A 60-day public comment Notice was published in the **Federal Register** on January 30, 2007. This comment period ended March 30, 2007. One public comment was received from this notice. This questioned whether the

AmeriCorps member or the program's Certifying Official should certify a member's prior service. The Corporation determined that the member should self-certify this information as it may not be available to the certifying official. A further suggestion to delete names of inactive program types will be implemented as appropriate.

*Description:* Currently, the Corporation is soliciting comments concerning the proposed renewal of its AmeriCorps Enrollment Form and its AmeriCorps Exit Form. The enrollment and exit forms are completed jointly by members interested in performing a period of national service and by programs providing that opportunity. Upon successfully completing a term of service an AmeriCorps participant may receive an education award that may be used to pay for certain educational expenses or for qualified student loans. Enrollment and exit processing is completed electronically. The paper forms are retained by the programs for audit purposes.

**POLICY JUSTIFICATION****France – Used E-2C Aircraft**

The Government of France has requested a possible sale of one (1) used E-2C aircraft with HAWKEYE 2000 Airborne Early Warning (AEW) Suite, three (3) T-56-A-427 spare engines, spare and repair parts, support equipment, personnel training and training equipment, publications and technical data, system software development and installation, ground/flight testing of new systems and system modifications, U.S. Government and contractor engineering and logistics support services, and other related elements of logistics support. The estimated cost is \$260 million.

This proposed sale will contribute to the foreign policy and national security objectives of the United States by improving the military capabilities of France while enhancing weapon system standardization and interoperability with U.S. forces.

France requires an additional E-2C aircraft to strengthen its AEW surveillance and enhanced command, control, and communications capabilities for both carrier and shore-based operations within their defense network. A fourth aircraft will ensure enhanced fleet communications and interoperability with North Atlantic Treaty Organization obligations. France will have no difficulty absorbing the additional E-2C aircraft into its armed forces.

This proposed sale will not adversely affect the military balance in the region.

There are no known offset agreements proposed in connection with this potential sale.

Implementation of this proposed sale will not require the assignment of any additional U.S. Government and contractor representatives to France.

There will be no adverse impact on U.S. defense readiness as a result of this proposed sale.

**(vii) Sensitivity of Technology:**

**1. The E-2C aircraft contains sensitive state-of-the art technology. Some of the hardware, publications, performance specifications, operational capability, parameters, vulnerabilities to countermeasures, and software documentation are classified Secret. The classified information to be provided is necessary for the operation, maintenance, and repair (through depot level) of the E-2C aircraft and it's installed systems and related software**

**2. The Hawkeye 2000 Airborne Early Warning (AEW) suite installed in the E-2C aircraft contains a mixture of newer and older technologies. Some of the hardware, publications, performance specifications, operational capability, parameters, vulnerabilities to countermeasures, and software documentation are classified Secret. The classified information to be provided consists of that which is necessary for the operation, maintenance and intermediate level repair of the E-2C airframe and the Hawkeye 2000 system as well as other installed and related software.**

**3. If a technologically advanced adversary were to obtain knowledge of the specific hardware and software, the information could be used to develop countermeasures that might reduce weapon system effectiveness or be used in the development of a system with similar or advanced capabilities.**
