### Notification of Request for Extension of Approval of Information Collection Activity—Notification Requirements for Sound Levels of Toy Caps

**AGENCY:** Consumer Product Safety Commission.

**ACTION:** Notice.

**SUMMARY:** In the July 3, 2008 *Federal Register* (73 FR 38186), the Consumer Product Safety Commission (CPSC or Commission) published a notice in accordance with provisions of the Paperwork Reduction Act of 1995 (44 U.S.C. Chapter 35) (PRA), to announce the agency's intention to seek extension of its PRA approval of information collection requirements regarding the sound levels of toy caps pursuant to 16 CFR 1500.18(a)(5). The Commission now announces that it has submitted to the Office of Management and Budget a request for extension of approval of that collection of information.

The Commission received no comments. The CPSC will use the information it obtains to monitor industry efforts to reduce the sound levels of toy caps, and to ascertain which firms are currently manufacturing or importing toy caps with peak sound levels between 138 and 158 decibels.

*Title of information collection:* Notification Requirements for Sound Levels of Toy Caps.

*Type of request:* Extension of approval.

*Frequency of collection:* Reports will be collected 4 times per year.

*General description of respondents:* Manufacturers or importers of toy caps.

*Estimated number of respondents:* 10 per year.

*Estimated average number of responses per respondent:* 4 per year.

*Estimated number of responses for all respondents:* 40 per year.

*Estimated number of hours per response:* 1 hour per response.

*Estimated number of hours for all respondents:* 40 hours per year.

*Estimated annual cost of collection to all respondents:* \$1,002 per year.

*Estimated total annual cost of the information collection requirements to the Federal Government:* \$10,321 per year.

*Description of the Air Force property:* Buckley Annex CO.

*Property Number:*

*Status:* Excess.

*Comments:* Buckley Annex is located on the western side of the former Lowry AFB and currently houses the Defense Finance and Accounting Service (DFAS) and the Air Reserve Personnel Center (ARPC). In 2005, BRAC legislation directed the relocation of ARPC to Buckley AFB and the realignment of DFAS, resulting in the ultimate closure of the site. The approximate 70 acre parcel contains one 605,000 Square Foot building and several smaller buildings to include a warehouse and office building located at 6760 E. Irvington Pl., in the City and County of Denver.

*Military construction sought:* After completion of a competitive bid process, the Air Force will enter into an agreement with the selected offeror/property recipient to construct military construction projects. The specific projects that will be constructed will depend on the amount of construction value offered by the prospective property recipient.

### Notice of Proposed Information Collection Requests

**AGENCY:** Department of Education.

**SUMMARY:** The IC Clearance Official, Regulatory Information Management Services, Office of Management, invites comments on the proposed information collection requests as required by the Paperwork Reduction Act of 1995.

**DATES:** Interested persons are invited to submit comments on or before November 24, 2008.

**SUPPLEMENTARY INFORMATION:** Section 3506 of the Paperwork Reduction Act of 1995 (44 U.S.C. Chapter 35) requires that the Office of Management and Budget (OMB) provide interested Federal agencies and the public an early opportunity to comment on information collection requests. OMB may amend or waive the requirement for public consultation to the extent that public participation in the approval process would defeat the purpose of the information collection, violate State or Federal law, or substantially interfere with any agency's ability to perform its statutory obligations. The IC Clearance Official, Regulatory Information Management Services, Office of Management, publishes that notice containing proposed information collection requests prior to submission of these requests to OMB. Each

proposed information collection, grouped by office, contains the following: (1) Type of review requested, e.g. new, revision, extension, existing or reinstatement; (2) Title; (3) Summary of the collection; (4) Description of the need for, and proposed use of, the information; (5) Respondents and frequency of collection; and (6) Reporting and/or Recordkeeping burden. OMB invites public comment.

The Department of Education is especially interested in public comment addressing the following issues: (1) Is this collection necessary to the proper functions of the Department; (2) will this information be processed and used in a timely manner; (3) is the estimate of burden accurate; (4) how might the Department enhance the quality, utility, and clarity of the information to be collected; and (5) how might the Department minimize the burden of this collection on the respondents, including through the use of information technology.

*Abstract:* The National Center for Education Statistics (NCES) is requesting an amendment to its three-year clearance for the Integrated Postsecondary Education Data System (IPEDS) to run for the 2008–09, 2009–10, and 2010–2011 web-based data collections. Current authorization for IPEDS expires July 31, 2011 (OMB No. 1850–0582). The Higher Education Opportunity Act (HEOA), which became law on August 14, 2008, after OMB had already granted IPEDS a three-year clearance, has several implications for the IPEDS annual Web-based data collection. The law requires the immediate implementation of several new institutional reporting requirements so that the data may be made available on the College Navigator Web site by August 2009. A change memo was sent to OMB on August 19, 2008, that included a small number of

non-substantive changes to the 2008–09 data collection based on the new requirements; OMB provided clearance for those changes in a notice on August 26, 2008. NCES now requests in this document a limited number of additional substantive changes to spring cycle of the 2008–09 IPEDS Web-based data collection, which opens on March 4, 2009, in order to implement HEOA requirements. These changes are to: (1) Make previously approved changes to financial aid reporting required, rather than optional, in spring 2009; (2) collect additional financial aid data; (3) collect data on students with disabilities; and (4) collect additional graduation rate data.

*Purpose of Program:* The Fulbright-Hays Doctoral Dissertation Research Abroad (DDRA) Fellowship Program

provides opportunities to doctoral candidates to engage in full-time dissertation research abroad in modern foreign languages and area studies. The program is designed to contribute to the development and improvement of the study of modern foreign languages and area studies in the United States.

*Priorities:* In accordance with 34 CFR 75.105(b)(2)(ii), this priority is from the regulations for this program (34 CFR 662.21(d)).

*Absolute Priority:* For FY 2009, this priority is an absolute priority. Under 34 CFR 75.105(c)(3) we consider only applications that meet this priority.

*This priority is:*

A research project that focuses on one or more of the following geographic areas: Africa, East Asia, Southeast Asia and the Pacific Islands, South Asia, the Near East, East Central Europe and Eurasia, and the Western Hemisphere (excluding the United States and its territories). Please note that applications that propose projects focused on Western Europe are not eligible.

Within this absolute priority, we give competitive preference to applications that address the following priority.

*Competitive Preference Priority:* For FY 2009, this priority is a competitive preference priority. Under 34 CFR 75.105(c)(2)(i) and 34 CFR 662.21(d)(2)(iii), we award an additional five (5) points to an application that meets this priority.

*This priority is:*

A research project that focuses on any of the seventy-eight (78) languages deemed critical on the U.S. Department of Education's list of Less Commonly Taught Languages (LCTLs) found below.
