Description of Project: The proposed run-of-river Indian River Hydroelectric Project will consist of: (1) A 6-foot-high, 30-foot-wide diversion structure, to be located at river mile (RM) 0.85; (2) a 40-inch-diameter, 1,550-foot-long penstock; (3) a 30-foot-wide, 40-foot-long, wood frame powerhouse, located at RM 0.55, housing a 250 kW turbine-synchronous generator; (4) a 50-foot-long tailrace returning flows back into Indian River; (5) a 5,900-foot-long transmission line; and (6) appurtenant facilities.
