City of Santa Barbara, California; Notice of Preliminary Determination of a Qualifying Conduit Hydropower Facility and Soliciting Comments and Motions To Intervene

On September 24, 2013, the City of Santa Barbara, California, filed a notice of intent to construct a qualifying conduit hydropower facility, pursuant to section 30 of the Federal Power Act, as amended by section 4 of the Hydropower Regulatory Efficiency Act of 2013 (HREA). The Gibraltar Conduit Hydroelectric Project would be located within the City of Santa Barbara’s existing water supply system, at the site

of a previously decommissioned hydroelectric plant. The plant is located at the outlet of the Gibraltar Conduit at the north end of the Lauro Reservoir in Santa Barbara County, California.

Qualifying Conduit Hydropower Facility Description: The proposed project would consist of: (1) An existing 16-inch diameter intake pipeline receiving water flows from an existing 21-inch diameter pipeline; (2) an existing powerhouse, containing one 820-kilowatt generating unit; (3) an existing 36-inch diameter discharge pipeline; and (4) appurtenant facilities. The proposed project would have an estimated annual generating capacity of 1,874 megawatt-hours.

A qualifying conduit hydropower facility is one that is determined or deemed to meet all of the criteria shown in the table below.
