**SUMMARY:** The Environmental Protection Agency has submitted an information collection request (ICR), "Laboratory Quality Assurance Evaluation Program for Analysis of *Cryptosporidium* under the Safe Drinking Water Act" (EPA ICR No. 2067.05, OMB Control No. 2040-0246) to the Office of Management and Budget (OMB) for review and approval in accordance with the Paperwork Reduction Act (44 U.S.C. 3501 *et seq.*). This is a proposed extension of the ICR, which is currently approved through January 31, 2014. Public comments were previously requested via the **Federal Register** (78 FR 54643) on September 5, 2013, during a 60-day comment period. This notice allows for an additional 30 days for public comments. A fuller description of the ICR is given below, including its estimated burden and cost to the public. An Agency may not conduct or sponsor and a person is not required to respond to a collection of information unless it displays a currently valid OMB control number.

**Abstract:** Under the Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR), EPA requires public water systems to use approved laboratories when conducting *Cryptosporidium* monitoring. The Code of Federal Regulations at 40 CFR 141.705(a) provides for approval of *Cryptosporidium* laboratories by "an equivalent" State laboratory certification program (i.e., equivalent to EPA's Laboratory Quality Assurance Evaluation Program). In the preamble to the LT2ESWTR as well as several other notices, EPA has described the criteria for approval of laboratories to analyze *Cryptosporidium* samples under the LT2ESWTR. Through today's notice, EPA is inviting comment on refinements

to the information collection approach to support EPA's Laboratory Quality Assurance Program.

**Respondents/affected entities:** Interested States and Laboratories.

**Respondent's obligation to respond:** Required to obtain or retain a benefit.

**Estimated number of respondents:** 45 laboratories and 20 States/Territories.

**Frequency of response:** Annual.

**Total estimated burden:** 5,472 hours (per year). Burden is defined at 5 CFR 1320.3(b).

**Total estimated cost:** \$803,774 (per year), includes \$295,056 annualized capital or operation & maintenance (O&M) costs.

**Changes in Estimates:** There is an increase of 629 hours in the total estimated respondent burden compared with the ICR currently approved by OMB. Changes in burden have occurred due to inflation, changes in the respondent universe, re-evaluation of hours for tasks, re-evaluation of O&M costs, and improved demonstration of capability. There is also new burden from states integrating *Cryptosporidium* into their existing certification programs, taking over this responsibility from the EPA.

**Abstract:** The New Source Performance Standards (NSPS) for the Graphic Arts Industry (40 CFR part 60, subpart QQ) were proposed on October 28, 1980, and promulgated on November 8, 1982. The affected entities are subject to the General Provisions of the NSPS at 40 CFR part 60, subpart A and any changes, or additions to the

Provisions specified at 40 CFR part 60, subpart QQ.

Owners or operators of the affected facilities must make an initial notification report, performance tests, periodic reports, and maintain records of the occurrence and duration of any startup, shutdown, or malfunction in the operation of an affected facility, or any period during which the monitoring system is inoperative. Reports are required semiannually at a minimum.

*Form Numbers:* None.

*Respondents/Affected Entities:* Graphic arts facilities.

*Respondent's Obligation to Respond:* Mandatory (40 CFR part 60, subpart QQ).

*Estimated Number of Respondents:* 20.33 (total).

*Frequency of Response:* Initially and semiannually.

*Total Estimated Burden:* 1,802 hours (per year). "Burden" is defined at 5 CFR 1320.3(b).

*Total Estimated Cost:* \$176,264 (per year), which also includes no annualized capital or operation & maintenance costs.

*Changes in the Estimates:* There is an increase in the total estimated respondent burden as currently identified in the OMB Inventory of Approved Burdens. The change in burden is due to an increase in the number of sources subject to these standards, and is not due to any program changes. The number of sources has been increased to account for industry growth that has occurred since the most-recent ICR was approved.

Also, there is an increase in the respondent cost from the most recently-approved ICR due to the use of updated labor rates. This ICR references labor rates from the Bureau of Labor Statistics to calculate the respondent burden cost.

There is a decrease in the total estimated Agency burden as compared to the most recently-approved ICR. This change is due to a revision in the labor burden estimate for repeat performance testing. Due to a discrepancy in the previous ICR, the labor burden for repeat performance testing included respondents who passed the initial performance test. The revision accounts only for respondents who failed the initial performance test resulted in the reduced labor burden observed in this ICR. Also, note that the ICR also incorporates updated labor rates from OPM.
