**ACTION:** Notice of extension of comment period.

**SUMMARY:** The United States Copyright Office is extending the deadline for public comments regarding the effectiveness of existing methods of licensing music that were solicited in a March 17, 2014 Notice of Inquiry. See 78 FR 14739 (Mar. 17, 2014).

**DATES:** Written comments are now due on or before May 23, 2014. The deadline for submitting requests to participate in the public roundtables on music licensing to be held in June 2014 in Nashville, Los Angeles, and New York remains May 20, 2014.

The U.S. Copyright Office is conducting a study to assess the effectiveness of current methods for licensing sound recordings and musical works. The Office published a Notice of Inquiry, seeking written comments on twenty-four subjects concerning the current environment in which music is licensed. See 78 FR 14739 (Mar. 17, 2014). The Office also published a Notice announcing public roundtables to be held in June 2014 in Nashville, Los Angeles, and New York. See 79 FR 25626 (May 5, 2014).
