- (I) Whether the contract was awarded on a noncompetitive basis, regardless of date of award.

Section 743(a)(3)(A) through (I) of the Consolidated Appropriations Act. Section 743(c) of the Consolidated Appropriations Act requires agencies to "publish in the Federal Register a notice that the inventory is available to the public."

Consequently, through this notice, we are announcing that the CPSC's service contract inventory for FY 2016 is available to the public. The inventory provides information on service contract actions of more than \$25,000 that CPSC made in FY 2016. The information is organized by function to show how contracted resources are distributed throughout the CPSC.
