**SUMMARY:** The Environmental Protection Agency has submitted an information collection request (ICR), NESHAP for Publicly Owned Treatment Works (EPA ICR Number 1891.10, OMB Control Number 2060–0428), to the Office of Management and Budget (OMB) for review and approval in accordance with the Paperwork Reduction Act. This is a proposed extension of the ICR, which is currently approved through March 31, 2019. Public comments were previously requested, via the **Federal Register**, on May 30, 2018 during a 60-day comment period. This notice allows for an additional 30 days for public comments. A fuller description of the ICR is given below, including its estimated burden and cost to the public. *Abstract:* The National Emissions Standards for Hazardous Air Pollutants (NESHAP) for Publicly Owned Treatment Works (POTW) (40 CFR part 63, subpart VVV) apply to both existing and new POTW located at a major source of hazardous air pollutants (HAP), or to Group 1 POTW that are either area or major sources. New facilities include those that either commenced construction or reconstruction after the date of proposal. This information is being collected to assure compliance with 40 CFR part 63, subpart VVV.

In general, all NESHAP standards require initial notifications, performance tests, and periodic reports by the owners/operators of the affected facilities. These notifications, reports, and records are essential in determining compliance, and are required of all affected facilities subject to NESHAP.

*Form Numbers:* None.

*Respondents/affected entities:* Owners and operators of publicly owned treatment works.

*Respondent's obligation to respond:* Mandatory (40 CFR part 63, subpart VVV).

*Estimated number of respondents:* 13 (total).

*Frequency of response:* Initially, occasionally, and semiannually.

*Total estimated burden:* 7 hours (per year). Burden is defined at 5 CFR 1320.3(b).

*Total estimated cost:* \$351 (per year), includes no annualized capital or operation & maintenance costs.

*Changes in the Estimates:* There is a decrease in the respondent burden from the most recently-approved ICR. This decrease is due to changes in the estimates. The previous ICR renewal had included burden for existing sources to submit periodic reports and maintain records; however, the 2016 amendments clarified that the 13 existing sources are not required to

submit periodic reports or maintain records.

*Abstract:* This ICR covers the collection of information from those organizations that receive cooperative agreements from EPA under the authority of the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) as amended by the Brownfields Utilization, Investment, and Local Development (BUILD) Act (Pub. L. 115-141). CERCLA, as amended, authorizes EPA to award grants or cooperative agreements to states, tribes, local governments, and other eligible entities to support the assessment and cleanup of brownfields sites. Under the Brownfields Amendments, a brownfields site means real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant. For funding purposes, EPA uses the term "brownfields property(ies)" synonymously with the term "brownfields sites." The Brownfields Amendments authorize EPA to award several types of cooperative agreements to eligible entities on a competitive basis.

Under subtitle A of the Small Business Liability Relief and Brownfields Revitalization Act, states, tribes, local governments, and other eligible entities can receive assessment cooperative agreements to inventory, characterize, assess, and conduct planning and community involvement related to brownfields properties; cleanup cooperative agreements to carry out cleanup activities at brownfields properties; multipurpose cooperative
