

Estimated Overall Grand Total Annual Reporting and Recordkeeping Burden: 112,543,753.58.

The currently approved burden for this information collection is 643,938,886 total annual responses and 77,690,005 total annual burden hours. Thus, when compared to the burden in the currently approved information collection, the adjustments in this renewal represent an increase of

293,854,398.93, rounded to 293,854,399, total annual responses and 34,853,748.58, rounded to 34,853,749, total annual burden hours. All burden changes associated with the renewal of this information collection are due to adjustments.

FNS is currently in the process of conducting less than ten consultations with State agencies and FNS staff regarding the accuracy of the burden

estimates in this information collection, including the validity of the methodology and assumptions that were used to estimate the burden. The inputs from those consultations will be considered, along with the public comments received in response to this notice, as FNS finalizes the burden estimate to be included in the request for OMB for approval.
