Iroquois Gas Transmission System, L.P.; Notice of Intent To Prepare an Environmental Impact Statement for the Proposed Enhancement By Compression Project and Schedule for Environmental Review

The staff of the Federal Energy Regulatory Commission (FERC or Commission) will prepare an environmental impact statement (EIS) for the Enhancement by Compression Project (Project), proposed by Iroquois

Gas Transmission System, L.P. (Iroquois) in Greene and Dutchess Counties, New York and Fairfield and New Haven Counties, Connecticut. The EIS will tier off Commission staff's Environmental Assessment (EA) and its findings and conclusions for the Project issued on September 30, 2020, and respond to comments filed on the EA.¹ The EIS will assist the Commission in its consideration of the Project's contribution to climate change and its decision-making process to determine whether Iroquois' proposed Project is in the public convenience and necessity. The schedule for preparation of the EIS is discussed in the "Schedule for Environmental Review" section of this notice.

The National Environmental Policy Act Process

The production of the EIS is part of the Commission's overall National Environmental Policy Act review process. Commission staff will independently analyze the proposed Project and prepare a draft EIS, which will be issued for public comment. Commission staff will consider all timely comments received during the comment period on the draft EIS and revise the document, as necessary, before issuing a final EIS. Any draft and final EIS will be available in electronic format in the public record through eLibrary² and the Commission's natural gas environmental documents web page (<https://www.ferc.gov/industries-data/natural-gas/environmental-environmental-documents>).

Schedule for Environmental Review

This notice identifies the Commission staff's planned schedule for completion of a final EIS for the Project, which is based on an issuance of the draft EIS in June 2021.

90-day Federal Authorization Decision Deadline December 2, 2021

If a schedule change becomes necessary for the final EIS, an additional notice will be provided so that the relevant agencies are kept informed of the Project's progress.

Proposed Consent Decree, Clean Air Act Citizen Suit

AGENCY: Environmental Protection Agency (EPA).

ACTION: Notice of proposed consent decree; request for public comment.

SUMMARY: In accordance with section the Clean Air Act, as amended (“CAA” or the “Act”), notice is given of a proposed consent decree in *Association of Irrigated Residents v. EPA*, No. 4:21-cv-426-JST (N.D. CA.). On January 17, 2021, Plaintiff filed a complaint in the United States District Court for the Northern District of California, Oakland Division, alleging that the Environmental Protection Agency (EPA) failed to perform several mandatory duties under the CAA. On May 10, 2019, the State of California submitted a SIP revision to EPA with two components titled “2018 Plan for the 1997, 2006, and 2012 PM_{2.5} Standards” and “San Joaquin Valley Supplement to the 2016 State Strategy for the State Implementation Plan” (together, the “SJV PM_{2.5} Plan”) to address CAA requirements for attainment of the PM_{2.5} NAAQS in the SJV Area. The SJV PM_{2.5} Plan includes measures intended to control emissions of fine particulate matter and its precursors within the San Joaquin Valley for purposes of attaining the 1997 annual and 24-hour PM_{2.5} NAAQS, 2006 24-hour PM_{2.5} NAAQS and 2012 annual PM_{2.5} NAAQS. The proposed consent decree would establish deadlines for EPA to take final actions on the portions of the SJV PM_{2.5} Plan that address requirements for the various PM_{2.5} NAAQS by specific dates.

DATES: Written comments on the proposed consent decree must be received by July 6, 2021.
