The proposed 6 units would have a total hydraulic capacity of approximately 2,636 cubic feet per second (cfs), as opposed to the total hydraulic capacity authorized for the 5 units of 2,295 cfs. The applicant states that this slight increase in the maximum hydraulic capacity should have no impact on fish entrainment since the inlet speed at the trashrack would still be well below the maximum inlet speed of 1.5 feet per second in the project license.
