#### Port Arthur LNG, LLC, PALNG Common Facilities Company, LLC; Notice of Amendment of Authorization and Establishing Intervention Deadline

Take notice that on June 21, 2023, Port Arthur LNG, LLC and PALNG Common Facilities Company, LLC (together referred to as PALNG), 488 8th Avenue, San Diego, CA 92101 filed an amendment under section 3 of the NGA to the existing authorization issued by the Commission on April 18, 2019, in Docket No. CP17–20–000 (2019 authorization or Liquefaction Project).<sup>1</sup> PALNG requests authorization to increase the peak workforce to up to 6,000 persons per day, implement a 24-hours-per-day construction schedule, and increase the number of onsite parking spaces to 1,000 for the Liquefaction Project which will allow PALNG to maintain a development schedule that will maximize construction efficiency and reduce

traffic congestion in the project area. PALNG's amendment request is on file with the Commission and open for public inspection.

Pursuant to section 157.9 of the Commission's Rules of Practice and Procedure,<sup>2</sup> within 90 days of this Notice the Commission staff will either: complete its environmental review and place it into the Commission's public record (eLibrary) for this proceeding; or issue a Notice of Schedule for Environmental Review. If a Notice of Schedule for Environmental Review is issued, it will indicate, among other milestones, the anticipated date for the Commission staff's issuance of the final environmental impact statement (FEIS) or environmental assessment (EA) for this proposal. The filing of an EA in the Commission's public record for this proceeding or the issuance of a Notice of Schedule for Environmental Review will serve to notify Federal and State agencies of the timing for the completion of all necessary reviews, and the subsequent need to complete all Federal authorizations within 90 days of the date of issuance of the Commission staff's FEIS or EA.

#### Public Participation

There are two ways to become involved in the Commission's review of this project: you can file comments on the project, and you can file a motion to intervene in the proceeding. There is no fee or cost for filing comments or intervening. The deadline for filing a
