#### **Humboldt-Toiyabe National Forest; Nevada; Withdrawal of Notice of Intent To Prepare an Environmental Impact Statement for the Humboldt-Toiyabe Integrated Invasive Plant Treatment Project**

**AGENCY:** Forest Service, Agriculture (USDA).

**ACTION:** Notice; withdrawal.

**SUMMARY:** The Humboldt-Toiyabe National Forest is withdrawing its notice of intent (NOI) to prepare an environmental impact statement (EIS) for the Humboldt-Toiyabe Integrated Invasive Plant Treatment Project.

With the change in the proposed action our preliminary analysis indicates there may not be effects that rise to a level of significance that would warrant an EIS.

### Export Trade Certificate of Review

**ACTION:** Notice of application for an amended Export Trade Certificate of Review for California Pistachio Export Council, LLC, Application No. 03-6A008.

**SUMMARY:** The Secretary of Commerce, through the Office of Trade and Economic Analysis (OTEA) of the International Trade Administration, has received an application for an amended Export Trade Certificate of Review (“Certificate”). This notice summarizes the proposed application and seeks public comments on whether the Certificate should be issued.

**SUPPLEMENTARY INFORMATION:** Title III of the Export Trading Company Act of 1982 (15 U.S.C. 4001–21) authorizes the Secretary of Commerce to issue Export Trade Certificates of Review. An Export Trade Certificate of Review protects the holder and the members identified in the Certificate from State and Federal government antitrust actions and from private treble damage antitrust actions for the export conduct specified in the Certificate and carried out in compliance with its terms and conditions. The regulations implementing Title III are found at 15 CFR part 325. OTEA is issuing this notice pursuant to 15 CFR 325.6(a), which requires the Secretary of Commerce to publish a summary of the application in the **Federal Register**, identifying the applicant and each member and summarizing the proposed export conduct.

#### Request for Public Comments

Interested parties may submit written comments relevant to the determination whether a Certificate should be issued. If the comments include any privileged or confidential business information, it must be clearly marked and a nonconfidential version of the comments (identified as such) should be included. Any comments not marked as privileged or confidential business information will be deemed to be nonconfidential.

Information submitted by any person is exempt from disclosure under the Freedom of Information Act (5 U.S.C. 552). However, nonconfidential versions of the comments will be made available to the applicant if necessary for determining whether or not to issue the

#### Certain Metal Lockers and Parts Thereof From the People’s Republic of China: Initiation and Expedited Preliminary Results of Changed Circumstances Reviews, and Intent To Revoke the Antidumping and Countervailing Duty Orders, in Part

**AGENCY:** Enforcement and Compliance, International Trade Administration, Department of Commerce.

**SUMMARY:** The U.S. Department of Commerce (Commerce) is initiating and issuing expedited preliminary results of changed circumstances reviews (CCR) of the antidumping duty (AD) and countervailing duty (CVD) orders on certain metal lockers and parts thereof (metal lockers) from the People’s Republic of China (China), to revoke the orders, in part, with respect to certain

gun safes. Interested parties are invited to comment on these preliminary results.

#### SUPPLEMENTARY INFORMATION:

##### Background

On August 20, 2021, Commerce published the AD and CVD orders on metal lockers from China.<sup>1</sup> On June 21, 2023, Tractor Supply Company (TSC), requested, through a CCR, the partial revocation of the *Orders* pursuant to section 751(b)(1)(A) of the Tariff Act of 1930, as amended (the Act), 19 CFR 351.216, and 19 CFR 351.221(c)(3)(ii).<sup>2</sup> TSC stated that it qualifies as an importer of certain gun safes currently subject to duties and, as such, is an interested party pursuant to section 771(9)(A) of the Act and 19 CFR 351.102(b)(29)(ii).<sup>3</sup>

On June 22, 2023, List Industries, Inc. (List) and Tenssco LLC (Tenssco), petitioners in the original investigations leading to the *Orders*, filed comments in support of partially revoking the *Orders* with regard to certain gun safes as defined in TSC’s request.<sup>4</sup> TSC’s Request includes additional letters of support from the domestic industry,<sup>5</sup> that, when including List and Tenssco’s support,<sup>6</sup> represents substantially all of the production of the domestic like product.<sup>7</sup> On July 10, 2023, TSC filed follow-up comments reiterating its previous request.<sup>8</sup>

##### Scope of the Orders

The scope of the *Orders* covers certain metal lockers, with or without doors, and parts thereof (metal lockers). The
