**SUMMARY:** FEMA gives notice that the minimum Project Worksheet Amount under the Public Assistance program for disasters and emergencies declared on or after October 1, 2023, will be increased.

FEMA gives notice of an increase to \$3,900 for the minimum amount that will be approved for any Project Worksheet under the Public Assistance program for all major disasters and emergencies declared on or after October 1, 2023.

FEMA bases the adjustment on an increase in the Consumer Price Index for All Urban Consumers of 3.7 percent for the 12-month period that ended in August 2023. This is based on information released by the Bureau of Labor Statistics at the U.S. Department of Labor on September 13, 2023.
