The New Cumberland Project would use the Corps' existing New Cumberland Locks and Dam and would consist of the following new facilities: (1) a 101-foot-wide, 193-foot-long reinforced concrete powerhouse; (2) a 90-foot-wide by 350-foot-long intake section with trash racks; (3) two identical Kaplan pit turbine-generators with a combined capacity of 19.99 megawatts; (4) a 13.8-kilovolt (kV), 180-foot-long underground utilidor crossing under the Norfolk Southern railway and transitioning to a 350-foot overhead transmission to the powerhouse-substation; (5) a 90-foot-wide by 90-foot-long powerhouse-substation; (6) a 1,050-foot-long, 34.5-kV, three-phase overhead transmission line connecting the powerhouse-substation to the existing 35-kV transmission line, east of Hancock County Bus Garage interconnection point in West Virginia; and (7) appurtenant facilities.
