Public Land Order No. 7942; Withdrawal of National Forest System Lands for the Guadalupe Cave Resources Protection Area; New Mexico

AGENCY: Bureau of Land Management, Interior.

ACTION: Public Land Order.

SUMMARY: This Order withdraws 28,513.30 acres of National Forest System lands in the Lincoln National Forest in Eddy County, New Mexico, from location and entry under the United States mining laws and from leasing under the mineral leasing laws for a period of 20 years, subject to valid

existing rights. The purpose of this withdrawal is to protect the Guadalupe Cave Resource Protection Area, which contains numerous known magnificent caves, including 88 caves listed as significant in accordance with the Federal Cave Resources Protection Act of 1988.

DATES: This Order takes effect on May 23, 2024.
