

(d) The United States, where the CFPB determines that litigation is likely to affect the CFPB or any of its components;

(8) Appropriate Federal, State, local, foreign, Tribal, or self-regulatory organizations or agencies responsible for investigating, prosecuting, enforcing, implementing, issuing, or carrying out a statute, rule, regulation, order, policy, or license if the information may be relevant to a potential violation of civil or criminal law, rule, regulation, order, policy, or license.

(9) The National Archives and Records Administration or other Federal Government agencies pursuant to records management inspections being conducted under the authority of 44 U.S.C. 2904 and 2906.

(10) A grand jury pursuant either to a Federal or State grand jury subpoena, or to a prosecution request that such record be released for the purpose of its introduction to a grand jury, where the subpoena or request has been specifically approved by a court. In those cases where the Federal Government is not a party to the proceeding, records may be disclosed if a subpoena has been signed by a judge; and

(11) A court, magistrate, or administrative tribunal in the course of an administrative proceeding or judicial proceeding, including disclosures to opposing counsel or witnesses (including expert witnesses) in the course of discovery or other pre-hearing exchanges of information, litigation, or settlement negotiations, where relevant or potentially relevant to a proceeding, or in connection with criminal law proceedings.

**SUMMARY:** The Consumer Product Safety Commission (CPSC), in accordance with Division C of the Consolidated Appropriations Act, 2010, is announcing the availability of CPSC’s service contract inventory for fiscal year (FY) 2022, CPSC’s FY 2021 service contract inventory analysis, and the plan for analyzing CPSC’s FY 2022 service contract inventory.

**SUPPLEMENTARY INFORMATION:** Section 743(a) of the Consolidated Appropriations Act, 2010 (Consolidated Appropriations Act), Public Law 111–117, titled “Service Contract Inventory Requirement,” requires agencies to submit to the Office of Management and Budget (OMB), an annual inventory of service contracts awarded or extended through the exercise of an option on or after April 1, 2010. The contents of the inventory must include:

(A) A description of the services purchased by the agency and the role the services played in achieving agency objectives, regardless of whether such a purchase was made through a contract or task order;

(B) The organizational component of the agency that is administering the contract, and the component whose requirements are being met through contractor performance of the service;

(C) The total dollar amount obligated for services under the contract and the funding source for the contract;

(D) The total dollar amount invoiced for services under the contract;

(E) The contract type and date of award;

(F) The name of the contractor and place of performance;

(G) The number and work location of contractor and subcontractor employees, expressed as full-time equivalents for direct labor, compensated under the contract;

(H) Whether the contract is a personal services contract; and

(I) Whether the contract was awarded on a noncompetitive basis, regardless of date of award.

Section 743(a)(3)(A) through (I) of the Consolidated Appropriations Act. Section 743(c) of the Consolidated Appropriations Act requires agencies to “publish in the **Federal Register** a notice that the inventory is available to the public.” OMB also requires that agencies submit an analysis of the previous year’s inventory, meaning the FY 2021 inventory under OMB’s schedule, and a plan for how the agency will analyze the current year’s inventory, which is the FY 2022 inventory under OMB’s current guidelines.

Consequently, through this notice, we are announcing that the CPSC’s service contract inventory for FY 2022 is available to the public.<sup>1</sup> The inventory

provides information on service contract actions that the CPSC made in FY 2022 per the Federal Acquisition Regulation (FAR) requirements in FAR part 4.1703. The information is organized by function to show how contracted resources are distributed throughout the CPSC. OMB posted a consolidated government-wide Service Contract Inventory for FY 2022 at <https://www.acquisition.gov/service-contract-inventory>. You can access the CPSC's inventories by limiting the "Contracting Agency Name" field on each spreadsheet to "Consumer Product Safety Commission."

*Abstract:* The Institute of Education Sciences (IES) is requesting clearance to administer surveys and follow-up interviews for a Congressionally mandated evaluation of the Innovative Assessment Demonstration Authority (IADA) program. Congress created the program to improve the quality and usefulness of assessments required under the Every Student Succeeds Act of 2015 (ESSA), by allowing the U.S. Department of Education (the Department) to exempt states that agree to pilot new assessments from certain testing requirements. IES had initially requested clearance in 2020 to survey participating IADA districts, schools, and teachers on the implementation of these new assessments. However, the COVID-19 pandemic and other challenges extensively slowed implementation, and two states have since withdrawn from IADA. As a result, there are few available districts, schools, and teachers that actually

administered the IADA assessment and could share their experiences in ways that would meaningfully contribute to this evaluation. IES is instead requesting to survey and conduct follow-up interviews with state assessment officials, technical advisors, and assessment vendors. Their perspectives will be more informative at this stage of the program and will lead to a much smaller overall burden on respondents.
