AGENCY: Department of Defense (DoD).

ACTION: Renewal of a Federal advisory committee.

SUMMARY: The DoD is publishing this notice to announce that it is renewing the Army Education Advisory Committee (AEAC).

SUPPLEMENTARY INFORMATION: The AEAC is being renewed in accordance with chapter 10 of title 5, United States Code (U.S.C.) (commonly known as the "Federal Advisory Committee Act" or "FACA") and 41 Code of Federal Regulations (CFR) 102-3.50(a). The charter and contact information for the Committee's Designated Federal Officer (DFO) are found at <https://www.faca.database.gov/FACA/apex/FACAPublicAgencyNavigation>.

The AEAC provides the Secretary of Defense, Deputy Secretary of Defense ("the DoD Appointing Authority"), and the Secretary of the Army independent advice and recommendations on U.S. Army educational matters. The AEAC will focus on matters pertaining to the educational doctrinal, and research policies and activities of the U.S. Army's educational programs, to include the U.S. Army's joint professional military education programs. The AEAC will assess and provide independent advice and recommendations across the spectrum of educational policies, school curricula, educational philosophy and objectives, program effectiveness, facilities, staff and faculty, instructional methods, and other aspects of the organization and management of these programs. The AEAC will also provide independent advice and recommendations on matters pertaining to the Army Historical Program and the role and mission of the U.S. Army Center of Military History, particularly as they pertain to the study and use of military history in Army schools. The AEAC shall be composed of 15 members. The membership will include: (a) fourteen individuals who are eminent authorities in the fields of defense, management, leadership, and academia, including those who are deemed to be historical scholars; and (b) the Chief Historian of the Army, U.S. Army, Center of Military History.

Individual AEAC members are appointed according to DoD policy and procedures and serve a term of service of one-to-four years with annual renewals. One member will be appointed as Chair of the AEAC. No member, unless approved according to DoD policy and procedures, may serve more than two consecutive terms of service on the AEAC, or serve on more than two DoD Federal advisory committees at one time.

AEAC members who are not full-time or permanent part-time Federal civilian

officers, employees, or active-duty members of the Uniformed Services will be appointed as experts or consultants, pursuant to 5 U.S.C. 3109, to serve as special government employee members. AEAC members who are full-time or permanent part-time Federal civilian officers or employees, or active-duty members of the Uniformed Services, will be appointed pursuant to 41 CFR 102-3.130(a), to serve as regular government employee members.

All members of the AEAC are appointed to provide advice on the basis of their best judgment without representing any particular point of view and in a manner that is free from conflict of interest. Except for reimbursement of official AEAC-related travel and per diem, members serve without compensation.

The public or interested organizations may submit written statements to the AEAC membership about the AEAC's mission and functions. Written statements may be submitted at any time or in response to the stated agenda of planned meeting of the AEAC. All written statements shall be submitted to the DFO for the AEAC, and this individual will ensure that the written statements are provided to the membership for their consideration.

Needs and Uses: Given the

devastating effects of Military Sexual Trauma (MST) and limited information on male MST specifically, the U.S. Congress specified a requirement to improve the prevention of and response to sexual trauma affecting male service members in the National Defense Authorization Act for Fiscal Year 2016 (Pub. L. 114-92). Furthermore, the DoD developed a formalized plan of action to improve prevention and response efforts for male MST. Despite these efforts and consistent with prior research, DoD reports found that active duty men are substantially less likely to report MST relative to active duty women counterparts. As part of the DoD-wide effort to promote help-seeking for sexual assault survivors, the DoN Office of Force Resiliency (OFR) developed and recently updated the Prevention Plan of Action (PPoA) (aka Prevention Plan of Action 2.0, 2022-2024; PPoA 2.0). The PPoA 2.0 is a strategy framework leveraging public health science in military environments to prevent sexual assault in the military and improve response efforts. As part of this initiative, OFR commissioned this study (Agreement #NMR-24-11717) to investigate the help-seeking among men who experienced military sexual

violence (*i.e.*, sexual assault or sexual harassment). The present study addresses this requirement by conducting interviews with men who have experienced military sexual violence.

Record of Decision: Issuance of a Loan Guarantee to Holtec Palisades, LLC for General Restoration and Maintenance Activities of the Palisades Nuclear Plant

AGENCY: Loan Programs Office (LPO), U.S. Department of Energy.

ACTION: Record of decision (ROD).

SUMMARY: The U.S. Department of Energy (DOE) announces its decision to issue a loan guarantee under the Energy Policy Act of 2005 (EPA 2005), as amended, specifically the Energy Infrastructure Reinvestment Program, to Holtec Palisades, LLC., (Holtec) for general restoration and maintenance activities (Project), consistent with the Nuclear Regulatory Commission (NRC) Renewed Facility Operating License Number DPR-20. The general

restoration and maintenance activities would support the potential future resumption of power generation activities at the Palisades Nuclear Plant (Palisades or PNP), an 800-MW electric nuclear generation station in Covert Township, Michigan. Holtec has initiated an exemption request, a license transfer request, and license amendment requests with NRC, that, if approved, would allow the resumption of power generation and operation until 2031, and Holtec intends to submit a subsequent license extension request to the NRC to allow power generation from 2031 to 2051.

SUPPLEMENTARY INFORMATION: The environmental impacts of general restoration and maintenance activities at PNP were analyzed pursuant to the National Environmental Policy Act (NEPA) in the *DOE/EIS-0562: Final Environmental Impact Statement, Proposed Palisades Nuclear Restart Project, Van Buren County, Michigan* (89 FR 53659, June 27, 2024).

The Project would entail general restoration and maintenance activities at PNP, consistent with the NRC Renewed Facility Operating License Number DPR-20. DOE LPO's review and adoption of the NRC NEPA documents covers only general restoration and maintenance activities, and the potential use of a DOE loan guarantee for PNP refueling, power ascension, and power generation would not occur until the completion of the NRC NEPA evaluation analyzing the same.

NEPA Review: Prior to DOE LPO consideration of a loan guarantee for the Project, PNP ceased operations, the nuclear fuel was removed, and PNP entered decommissioning mode in May 2022. The nuclear fuel was placed in the established onsite spent fuel pool, but no structural dismantling of PNP has occurred, and the equipment is still in place and intact. Palisades was acquired by Holtec in June 2022, who now
