

MI, beginning at Lighthouse Beach and encompassing all U.S. waters of the St. Clair River bound by a line starting at a point on land north of Coast Guard Station Port Huron at position 43°00.416' N; 082°25.333' W, extending east to the international boundary to a point at position 43°00.416' N; 082°25.033' W, following south along the international boundary to a point at position 42°54.500' N; 082°27.683' W, extending west to a point on land just north of Stag Island at position 42°54.500' N; 082°27.966' W, and following north along the U.S. shoreline to the point of origin (NAD 83). (WGS 84).

(b) *Enforcement period.* The safety zone described in paragraph (a) will be enforced from 12 p.m. through 7 p.m. on August, 18, 2024.

(c) *Regulations.* (1) In accordance with the general regulations in § 165.23, entry into, transiting, or anchoring within the safety zones described in paragraph (a) is prohibited unless authorized by the COTP Detroit or a designated on-scene representative.

(2) The safety zones are closed to all vessel traffic, except as may be permitted by the COTP Detroit or a designated on-scene representative.

(3) The “on-scene representative” of the COTP Detroit is any Coast Guard commissioned, warrant or petty officer or a federal, state, or local law enforcement officer designated by the COTP Detroit to act on his behalf.

(4) Vessel operators desiring to enter or operate within the safety zones must contact the COTP Detroit or an on-scene representative to obtain permission to do so. The COTP Detroit or an on-scene representative may be contacted via VHF Channel 16. Vessel operators given permission to enter or operate in the safety zone must comply with all directions given to them by the COTP Detroit or an on-scene representative.

#### Safety Zones; Recurring Safety Zones in Captain of the Port Northern Great Lakes Zone

**AGENCY:** Coast Guard, DHS.

**ACTION:** Notification of enforcement of regulation.

**SUMMARY:** The Coast Guard will enforce various safety zones in August 2024 for marine events taking place in Captain of the Port Northern Great Lakes.

Enforcement of these safety zones is necessary to protect the safety of life and property on the navigable waters immediately prior to, during, and immediately after events. During the period, the Coast Guard will enforce restrictions upon, and control movement of, vessels in a specified area immediately prior to, during, and immediately after events. During each enforcement period, vessels must stay out of the established safety zone and may only enter with permission from the Captain of the Port Northern Great Lakes or a designated representative.

**DATES:** The regulations listed in 33 CFR 165.918 will be enforced for the safety zones identified in the **SUPPLEMENTARY INFORMATION** section for the dates and times specified.

**SUPPLEMENTARY INFORMATION:** The Coast Guard will enforce the safety zones in 33 CFR 165.918 as per the time, dates, and locations indicated below:

(1) Elk Rapids Harbor Days Fireworks (Elk Rapids, MI; East Arm Grand Traverse Bay, Lake Michigan) from 10:00 p.m. through 10:30 p.m. on August 3, 2024.

(2) Nautical City Fireworks (Rogers City, MI; Lake Huron) from 10:00 p.m. through 10:30 p.m. on August 4, 2024. This notice also includes an alternative rain date from 10:00 p.m. through 10:30 p.m. on August 11, 2024.

This notice of enforcement is issued under authority of 33 CFR 165.918 and 5 U.S.C. 552 (a). In addition to this notice of enforcement in the **Federal Register**, the Coast Guard will provide

the maritime community with advance notification of this enforcement period via Broadcast Notice to Mariners or Local Notice to Mariners. If the Captain of the Port Northern Great Lakes determines that the safety zone need not be enforced for the full duration stated in this notice, he or she may suspend such enforcement and notify the public of the suspension via Broadcast Notice to Mariners and grant general permission to enter the respective safety zone.

**AGENCY:** Coast Guard, DHS).

**ACTION:** Final rule; correcting amendment.

**SUMMARY:** The Coast Guard published a document in the **Federal Register** on July 19, 2024, revising its existing regulations by updating the table for existing events in the Seventh Coast Guard District Captain of the Port (COTP) Key West. The document contained an incorrect footnote reference.

**SUPPLEMENTARY INFORMATION:** The document published on July 19, 2024, at FR doc. 2024–15552, contained an error in the regulatory text set out in instruction 2, revising section (b), in table 1 to 33 CFR 100.701. In section (b), in table 1 § 100.701, line number 4, column number 4, there is a footnote 1; however, there is no text for footnote 1. Reference to footnote 1 will be removed from the regulatory text.

**Potassium Carbonate; Exemption From the Requirement of a Tolerance**

**AGENCY:** Environmental Protection Agency (EPA).  
**ACTION:** Final rule.

**SUMMARY:** This regulation establishes an exemption from the requirement of a tolerance for residues of potassium carbonate in or on all food commodities when used as a biochemical fungicide in accordance with label directions and good agricultural practices. Biofungitek, S.L. submitted a petition, pursuant to section 408(d) of the Federal Food, Drug, and Cosmetic Act (FFDCA),

requesting an exemption from the requirement of a tolerance for the biochemical pesticide potassium carbonate. This regulation eliminates the need to establish a maximum permissible level for residues of potassium carbonate under FFDCA when used in accordance with this exemption.

**DATES:** This regulation is effective August 5, 2024. Objections and requests for hearings must be received on or before October 4, 2024 and must be filed in accordance with the instructions provided in 40 CFR part 178 (see also Unit I.C. of the **SUPPLEMENTARY INFORMATION**).
