SUPPLEMENTARY INFORMATION: The National Science Foundation, as directed by the Antarctic Conservation Act of 1978 (Pub. L. 95–541, 45 CFR 670), as amended by the Antarctic Science, Tourism and Conservation Act of 1996, has developed regulations for the establishment of a permit system for various activities in Antarctica and designation of certain animals and certain geographic areas as requiring special protection. The regulations establish such a permit system to designate Antarctic Specially Protected Areas.

Application Details

Permit Application: 2025–012

1. *Applicant:* Heather Lynch, Stony Brook University, IACS 163, Stony Brook, NY 11794

Activity for Which Permit is Requested: Harmful Interference, Enter Antarctic Specially Protected Areas. The applicant would survey chinstrap penguin (*Pygoscelis antarctica*) colonies in the South Shetland Islands including multiple sites on Low Island. The outcomes of the surveys would be useful in determining population abundance and distribution of chinstrap penguins, important consumers of Antarctic krill. Surveys would be completed using direct manual counts (on foot) and by operating small, remotely piloted aircraft systems (RPAS) over colonies. RPAS would be operated by experienced pilots at altitudes of at least 30 meters above wildlife. Although no significant disturbance is expected, both manual counts and RPAS overflights have the potential to disturb chinstrap penguins as well as Adelie penguins (*Pygoscelis adeliae*), Gentoo penguins (*Pygoscelis papua*), the Southern giant petrel (*Macronectes giganteus*), Southern fulmar (*Fulmarus*

glacialisoides), Cape petrel (*Deception capense*), Antarctic blue-eyed shag (*Phalacrocorax atriceps*), Antarctic brown skua (*Catharacta antarctica*), South polar skua (*Catharacta maccormicki*), Kelp gull (*Larus dominicanus*), and the Antarctic tern (*Sterna vittata*) based on the location of the surveys. While conducting visitor site surveys and censuses, the applicant would potentially enter a number of Antarctic Specially Protected Areas (ASPAs) in the Antarctic Peninsula region.

Location: King George Island, South Shetland Islands, Robert Island, Livingston Island; Western Antarctic Peninsula; ASPA 112, Coppermine Peninsula, Robert Island, South Shetland Islands; ASPA 125, Fildes Peninsula, King George Island (25 de Mayo); ASPA 126 Byers Peninsula, Livingston Island, South Shetland Islands; ASPA 128, Western shore of Admiralty Bay, King George Island, South Shetland Islands; ASPA 132, Potter Peninsula, King George Island (Isla 25 de Mayo, South Shetland Islands; ASPA 133, Harmony Point, Nelson Island, South Shetland Islands; ASPA 134, Cierva Point and offshore islands, Danco Coast, Antarctic Peninsula; ASPA 139, Biscoe Point, Anvers Island, Palmer Archipelago; ASPA 150, Ardley Island, Maxwell Bay, King George Island (25 de Mayo); ASPA 151, Lions Rump, King George Island, South Shetland Islands; ASPA 171, Narebski Point, Barton Peninsula, King George Island; ASPA 180, Danger Islands; ASPA 182, Western Bransfield Strait and Eastern Dallman Bay.

AGENCY: Nuclear Regulatory Commission.

ACTION: Construction permit application; Notice of uncontested hearing.

SUMMARY: The U.S. Nuclear Regulatory Commission (NRC or the Commission) will commence an uncontested hearing, in which the Commission will receive

written evidence in the form of testimony and exhibits regarding the application from Kairos Power LLC (Kairos) for a construction permit (CP) to construct a non-power test reactor termed Hermes 2 in Oak Ridge, Tennessee.

SUPPLEMENTARY INFORMATION:

I. Background

The Commission hereby gives notice that, pursuant to Section 189a of the Atomic Energy Act (AEA) of 1954, as amended, it will commence an uncontested hearing, in which the Commission will receive written evidence in the form of testimony and exhibits regarding the application from Kairos for a CP to construct a non-power test reactor facility termed Hermes 2 in Oak Ridge, Tennessee.

Kairos's application was submitted by letter on July 14, 2023. Agencywide Documents Access and Management System (ADAMS) Accession No. ML23195A122.

The NRC staff's Environmental Assessment (including its Finding of No Significant Impact) and Safety Evaluation Report may be viewed at ADAMS Accession Nos. ML24240A034 and ML24200A115, respectively. This mandatory hearing will concern safety and environmental matters relating to the requested construction permit application, as more fully described below.

II. Evidentiary Uncontested Hearing

The Commission will conduct this hearing using written materials only. The schedule and process for submitting written materials to the Commission is detailed in Sections V and VI below. The parties to this proceeding are Kairos and the NRC staff.

III. Presiding Officer

The Commission is the presiding officer for this proceeding.

IV. Matters To Be Considered

The matter at issue in this proceeding is whether the review of the Kairos Hermes 2 construction permit application by the Commission's staff has been adequate to support the findings found in title 10 of the *Code of Federal Regulations* (10 CFR) 50.35, 50.40, 50.50, and 10 CFR 51.105. Those findings are as follows:

Issues Pursuant to the Atomic Energy Act of 1954, as Amended

With respect to the construction permit: (1) whether the applicant has described the proposed design of the facility, including, but not limited to, the principal architectural and engineering criteria for the design, and has identified the major features or components incorporated therein for the protection of the health and safety of the public; (2) whether such further technical or design information as may be required to complete the safety analysis, and which can reasonably be left for later consideration, will be

supplied in the final safety analysis report; (3) whether safety features or components, if any, which require research and development have been described by the applicant and the applicant has identified, and there will be conducted, a research and development program reasonably designed to resolve any safety questions associated with such features or components; (4) whether on the basis of the foregoing, there is reasonable assurance that (i) such safety questions will be satisfactorily resolved at or before the latest date stated in the application for completion of construction of the proposed facility, and (ii) taking into consideration the site criteria contained in 10 CFR part 100, the proposed facility can be constructed and operated at the proposed location without undue risk to the health and safety of the public; (5) whether there is reasonable assurance (i) that the construction of the facility will not endanger the health and safety of the public, and (ii) that construction activities can be conducted in compliance with the Commission's regulations; (6) whether the applicant is technically and financially qualified to engage in the proposed activities in accordance with the Commission's regulations in Chapter I of 10 CFR; (7) whether the issuance of a permit for the construction of the facility to the applicant will not, in the opinion of the Commission, be inimical to the common defense and security or to the health and safety of the public; and (8) whether the application meets the standards and requirements of the AEA and the Commission's regulations, and that notifications, if any, to other agencies or bodies have been duly made.

Issues Pursuant to the National Environmental Policy Act (NEPA) of 1969

With respect to the construction permit: (1) determine whether the requirements of Sections 102(2)(A), (C), and (E) of NEPA and the applicable regulations in 10 CFR part 51 have been met; (2) independently consider the final balance among conflicting factors contained in the record of the proceeding with a view to determining the appropriate action to be taken; (3) determine, after weighing the environmental, economic, technical, and other benefits against environmental and other costs, and considering reasonable alternatives, whether the construction permit should be issued, denied, or appropriately conditioned to protect environmental values; and (4) determine whether the

NEPA review conducted by the NRC staff has been adequate.

V. Schedule for Submittal of Written Evidence

All documents to be filed by the parties as described below should be filed in accordance with the requirements of our E-filing rules at 10 CFR 2.304(g) and will be considered exhibits in this proceeding once filed.

No later than October 10, 2024, the NRC staff should E-file the following documents to add them to the docket for this hearing: (1) SECY-24-0075, which will serve as the NRC staff's primary written testimony in this hearing, (2) the construction permit application,¹ (3) the draft construction permit, (4) the safety evaluation, (5) the environmental assessment and finding of no significant impact, and (6) any report submitted by the Advisory Committee on Reactor Safeguards in compliance with section 182(b) of the AEA and 10 CFR 50.58(a) regarding the Hermes 2 construction permit and any NRC staff response thereto. If any of these documents are non-public, then the NRC staff should also file a public version, if practicable.

No later than September 26, 2024, the Commission may issue written questions to one or both of the parties (the NRC staff and the applicant). If such questions are issued, party testimony responding to such questions, and associated exhibits (if any), are due October 10, 2024, unless the Commission directs otherwise. The applicant may also file additional written testimony by October 10, 2024.

VI. Interested Government Participants

No later than September 20, 2024, any interested State, local government body, or Federally recognized Indian Tribe may file with the Commission a statement of any issues or questions that the State, local government body, or Indian Tribe wishes the Commission to give particular attention to as part of the uncontested hearing process. Such statement may be accompanied by any supporting documentation that the State, local government body, or Indian Tribe sees fit to provide. Any statements and supporting documentation (if any) received by the Commission using the agency's E-filing system² by the

deadline indicated above will be made part of the record of the proceeding. The Commission will use such statements and documents as appropriate to inform its questions to the NRC staff and applicant and its hearing decision.

Many of the procedures and rights applicable to the inherently adversarial nature of NRC's contested hearing process are not available in this uncontested hearing. Participation in the NRC's contested hearing process is governed by 10 CFR 2.309 (for persons or entities, including a State, local government, or Indian Tribe seeking to file contentions of their own) and 10 CFR 2.315(c) (for an interested State, local government, or Federally recognized Indian Tribe seeking to participate with respect to contentions filed by others). Participation in this uncontested hearing does not affect the right of a State, a local government, or an Indian Tribe to participate in a separate contested hearing process.
