#### **Cheyenne Plains Gas Pipeline Company, LLC and Natural Gas Pipeline Company of America, LLC; Notice of Application and Establishing Intervention Deadline**

Take notice that on September 20, 2024, Cheyenne Plains Gas Pipeline Company, LLC (Cheyenne Plains), P.O. The Capacity Lease Agreement would allow Cheyenne Plains to provide a new firm service (combining transportation and storage services) to Southwestern Public Service Company to support its Harrington Power Plant electric generation facility,<sup>2</sup> all as more fully set
