Take notice that on September 30, 2024, Tennessee Gas Pipeline, L.L.C. (Tennessee), 1001 Louisiana Street, Suite 1000, Houston, Texas 77002, filed an application under section 7(b) of the Natural Gas Act (NGA), and Part 157 of the Commission's regulations requesting authorization for its 507G Line Abandonment Project (Project). The Project consists of the abandonment in place and by removal of a portion of Tennessee's mainline pipeline, Line 507G-100, consisting of approximately 75.38 miles of 16-inch-diameter pipeline and associated appurtenances; and the abandonment of a pipeline supply lateral, Line 507G–500, consisting of approximately 9.05 miles of 12-inch-diameter pipeline and associated appurtenances. The Project facilities are located in Acadia, Vermilion, Iberia, and St. Mary Parishes, Louisiana. Tennessee estimates the total cost of the Project to be \$46.4 million, all as more fully set forth in the

application which is on file with the Commission and open for public inspection.

If a Notice of Schedule for Environmental Review is issued, it will indicate, among other milestones, the anticipated date for the Commission staff's issuance of the final environmental impact statement (FEIS) or environmental assessment (EA) for this proposal. The filing of an EA in the Commission's public record for this proceeding or the issuance of a Notice of Schedule for Environmental Review will serve to notify federal and state agencies of the timing for the completion of all necessary reviews, and the subsequent need to complete all federal authorizations within 90 days of the date of issuance of the Commission staff's FEIS or EA.
