#### **Southern Natural Gas Company, L.L.C.; Notice of Application and Establishing Intervention Deadline**

Take notice that on October 15, 2024, Southern Natural Gas Company, L.L.C. (Southern), 569 Brookwood Village, Suite 600, Birmingham, Alabama 35209, filed an application pursuant to section 7(c) of the Natural Gas Act (NGA), and Part 157 of the Commission's regulations to amend facilities previously authorized as part of the Bessemer Calera Expansion Project (Project) in Docket No. CP24-32-000 pursuant to Southern's blanket certificate. Southern requests authorization to install a 1.63-mile-long segment of pipeline looping with an 8-inch-diameter pipeline in place of the originally authorized 4-inch-diameter pipeline, located in Shelby County, Alabama (Longview Lateral Loop). Southern states that the increased diameter will not change Project capacity, which was fully subscribed by Spire Alabama Inc. (Spire), but rather increase pressure stability, providing Spire operational flexibility and greater reliability in serving industrial and residential customers in the area. Southern estimates the total cost of the Project to increase by approximately \$2 million, to a total of \$27 million, all as more fully set forth in the application

which is on file with the Commission and open for public inspection.

If a Notice of Schedule for Environmental Review is issued, it will indicate, among other milestones, the anticipated date for the Commission staff's issuance of the final environmental impact statement (FEIS) or environmental assessment (EA) for this proposal. The filing of an EA in the Commission's public record for this proceeding or the issuance of a Notice of Schedule for Environmental Review will serve to notify federal and state agencies of the timing for the completion of all necessary reviews, and the subsequent need to complete all federal authorizations within 90 days of the date of issuance of the Commission staff's FEIS or EA.

## Public Participation

A protest may also serve as a motion to intervene so long as the protestor states it also seeks to be an intervenor.

The Commission considers all comments received about the project in determining the appropriate action to be taken. *However, the filing of a comment alone will not serve to make the filer a party to the proceeding.* To become a party, you must intervene in the proceeding. ### Interventions

Any person, which includes individuals, organizations, businesses, municipalities, and other entities,<sup>6</sup> has the option to file a motion to intervene in this proceeding. Only intervenors have the right to request rehearing of Commission orders issued in this proceeding and to subsequently

challenge the Commission's orders in the U.S. Circuit Courts of Appeal.

To intervene, you must submit a motion to intervene to the Commission in accordance with Rule 214 of the Commission's Rules of Practice and Procedure<sup>7</sup> and the regulations under the NGA<sup>8</sup> by the intervention deadline for the project, which is November 6, 2024.
