**SUMMARY:** In accordance with section 122(h) of the Comprehensive Environmental Response, Compensation, and Liability Act of 1980 (CERCLA), notice is hereby given by the

U.S. Environmental Protection Agency (EPA), Region 3, of a proposed cost recovery settlement agreement (Settlement) pursuant to CERCLA with U.S. Home, LLC, d/b/a Lennar, and B&J Excavating, Inc. (Settling Parties) relating to the A.I.W. Frank/Mid-County Mustang Superfund Site (Site), located in Exton, Chester County, Pennsylvania.

The Settling Parties will pay to the EPA \$178,818.46, plus interest on this total amount calculated from the date of the EPA's demand letters to the Settling Parties through the date of payment. The Settlement includes a covenant by the EPA not to sue or to take administrative action against Settling Parties pursuant to Section 107(a) of CERCLA, 42 U.S.C. 9607(a), with regard to the EPA's past response costs as provided in the Settlement. For thirty (30) days following the date of publication of this notice, the EPA will receive written comments relating to the proposed Settlement. The EPA will consider all comments received and may modify or withdraw its consent to the proposed Settlement if comments received disclose facts or considerations that indicate that the proposed Settlement is inappropriate, improper, or inadequate.
